LEGAL DEFENCE

Ben is one of the company's drivers. While on the job, he receives a speeding ticket he wishes to dispute.

LEGAL DEFENCE

Due to a highway closure, Kathy is charged with driving over the maximum number of hours allowed in a 24-hour period.

CONTRACT DISPUTES

Harman takes his truck to the repair shop for brake work. Following the repairs, he notices that the brake issue has gotten worse. The garage refuses to rectify the issue.

DAS will instruct a lawyer and cover legal costs to deal with the garage and negotiate repairs or a refund.

DRIVER'S LICENCE PROTECTION

Yang's driver's licence is suspended. His business activities require him to drive.

DAS will appoint a lawyer and cover legal fees to appeal the decision.

STATUTORY LICENCE PROTECTION

Following an accident, the Ministry threatens to revoke Asha's safety rating certificate.

DAS will cover legal costs and provide legal representation to appeal the decision.

STATUTORY LICENCE PROTECTION

A business is assigned a conditional safety rating following a failed facility audit. The business has since fixed the issue that resulted in the failed audit, but the Ministry refuses to amend the conditional rating at renewal time.
