- A driver received 2 tickets: one for failing to have a logbook of the last 14 days on the road, and one for failing to complete the logbook after inspection.
DAS appointed a legal representative who negotiated with the prosecutor for a withdrawal of the first offence.
- A florist shop takes their delivery vehicle in for transmission repairs. Following the repairs, the transmission issues worsen and the vehicle is left stranded on the side of the road. The garage refuses to rectify the issue.
DAS instructed a lawyer and covered all legal costs to deal with the garage and negotiate a refund for past work.
